The Lieutenant-Governor as Administrator of the Union territory of Puducherry, hereby notifies the the re-issue of 7.25% Puducherry SDL 2032 issued on January 25, 2017 for an aggregate amount of ₹100 crore (Rupees one hundred crore only) [Nominal]. The sale will be subject to the terms and conditions spelt out in this notification (called Specific Notification), as also the terms and conditions specified in the General Notification in G.O. Method of issue.— Government Stock will be sold through the Reserve Bank of India, Mumbai Office (PDO), Fort, Mumbai-400 001 by auction in the manner as prescribed in paragraph 6.1 of the General Notification in G.O.
