NOTIFICATION

Ms. No. 19/93-Wel(SW-I), dated 06th April, 1993 and G.O. Ms. No. 1/SWS/2021-22, dated 24-08-2021 of the Under Secretary to Government (Social Welfare), Puducherry as follows, namely:

AMENDMENT

1. Short title and commencement.— (i) These rules may be called the "Financial Assistance to Differently Abled Persons (Amendment) Rules, 2024".

(ii) They shall come into force with effect from the date of issue of notification.

2. Amendment of rule 3.— In the Financial Assistance to Differently Abled Persons Rules, 1993, for rule 3 of the Amendment Rules vide G.O. Ms. No. 1/SWS/2021-22, dated 24-08-2021, the following rule shall be substituted namely:-

3. Subject to the provisions of rule 4, assistance may be enhanced to the Differently Abled Persons under the monthly Financial Assistance to the Differently Abled Persons Scheme as indicated below at following rates as amended and mentioned against respective disablement:-
