Amendments to the rules notified in G.O. Ms. No. 17/2003-Wel(SCW.II), dated 22-09-2003 of Welfare Secretariat, Pondicherry and published in the Part-II, Extraordinary Gazette of Pondicherry, No. 22, dated 23rd September, 2003, namely:

AMENDMENT

In the Rules for award of Pre-Matric Scholarship to Scheduled Caste/Scheduled Tribes students studying from VI Standard to X Standard, 2003, for rule 5, the following shall be substituted, namely:-

5. *Amount of Scholarship.*— The scholarship shall be granted for 10 months in an Academic Year at the following rates:-

VI Standard to VIII Standard - ₹ 500 (Rupees five hundred only) per month.

IX Standard to X Standard - ₹ 800 (Rupees eight hundred only) per month.

2. These orders shall be deemed to have come into effect from the Academic Year 2025-26.
