(G.O. Ms. No. 8, Puducherry, dated 19th March 2025)

ORDER

The Department of Revenue and Disaster Management, Government of Puducherry, is entrusted with the issuance of various Certificates, viz., Caste/Community, Residence/Nativity, Income, Economically Weaker Sections (EWS) Certificates, etc., to the Applicants who require the same to avail various benefits from the Government, including reservation in Educational Institutions and employment in various Government Departments, Institutions and Public Sector Undertakings.

2. The Caste/Community Certificates are issued to the Applicants belonging to Other Backward Classes (OBCs)/Most Backward Classes (MBCs)/Extreme Backward Classes (EBCs)/Backward Class Muslims (BCMs)/Backward Tribes (BTs) in relation to the Union territory of Puducherry for determining their eligibility for availing benefits of reservation in education and/or employment and other welfare measures that are extended by the Government of Puducherry to the ordinary residents of the Union territory of Puducherry. In all such cases, the ordinary residential status of the Applicants as on the crucial date has to be verified. In the Notification issued *vide* G.O. Ms. No. 9/2001-Wel (SW-II), dated 19-02-2001 of the Chief Secretariat (Welfare), Government of Puducherry, the List of Castes/Communities have been notified as Other Backward Classes eligible for the benefits, *viz.*, reservation in employment as well as in Educational Institutions and socio-economic benefits provided in this Union territory of Puducherry Administration. The cut-off date for determining the status of the origin/migrant Other Backward Classes, in the Union territory of Puducherry has been declared as "19th February, 2001" *vide* G.O. Ms. No. 15/SWS/2019-20, dated 07-08-2019 of the Social Welfare Secretariat, Government of Puducherry. The Notification issued *vide* G.O. Ms. No. 9/2001-Wel (SW-II), dated 19-02-2001 of the Chief Secretariat (Welfare), Government of Puducherry and subsequent Notifications adding Castes/Communities have been issued from time to time based on the recommendations of the State Level Commission for Backward Classes. Accordingly, some of the Castes/Communities out of the overall Other Backward Classes/ Castes were categorised as 'Most Backward Classes', 'Backward Tribes', 'Backward Class Muslims' and 'Extreme Backward Classes' issued *vide* G.O. Ms. No. 27/2004-Wel (SW-V), dated 14-07-2004; G.O. Ms. No. 6/2010-Wel/SW-V, dated 09-06-2010; G.O. Ms. No. 8/2010-WEL/SW-V, dated 28-08-2010; and G.O. Ms. No. 9/2010/Wel/SW-V, dated 28-08-2010 of the Chief Secretariat (Welfare), Government of Puducherry, respectively. As the entries in the List of OBC is the primary requirement for further categorisation into MBC/EBC/BCM/BT and as they were drawn out of the OBC List notified on 19-02-2001, including/excluding/ altering the Castes/Communities added to/omitted from/amending the said List, as the case may be, the crucial date to decide "Ordinary residence" shall remain as "19th February, 2001". Accordingly, the

Revenue Authorities shall ascertain that the Applicant is/was an ordinary resident in the Union Territory on the crucial date which requires the Applicant to furnish various documentary proofs, and if, the present place of ordinary residence and the place of ordinary residence on the crucial date are falling in different Revenue Villages/Taluku (within the jurisdiction of Union territory of Puducherry), it necessitates the field enquiry and report by the Revenue Officials of the respective jurisdictions in which they have resided, for determining ordinary residential status of the Applicant claiming to be belonging to OBC/MBC/EBC/BCM/BT in the Union territory of Puducherry, as on the crucial date while issuing such Certificate(s).

3. In order to streamline the process of issuance of Caste/Community Certificate and after careful examination of the facts and considering the necessity of curtailing the delay in issuing the said Certificates, it has been decided to introduce a modified system of issuance of Certificate in the form of a Caste/Community Certificate for OBC/MBC/EBC/BCM/BT, which is permanent for life time of the Applicant. Therefore, it is hereby ordered to issue Caste/Community Certificate for OBC/MBC/EBC/ BCM/BT, with lifetime validity to the eligible Applicants as detailed below with immediate effect:

(i) The Caste/Community Certificate shall be issued to the eligible Applicant claiming the OBC/MBC/EBC/BCM/BT of Puducherry within the jurisdiction of Union territory of Puducherry, after one-time verification and scrutiny by the Certificate issuing Authorities and certification of the Applicant's Caste/Community of Puducherry with a validity period for his/her lifetime, unless he/she converts to other religion/denotification of his/her Caste/Community. An Applicant is said to be belonging to the OBC/MBC/EBC/BCM/BT of Puducherry, if, he/she or his/her forefather is/was an ordinary resident of the Union territory of Puducherry as on the crucial date/cut-off date, *i.e.*, 19th February, 2001.

(ii) The details of the OBC/MBC/EBC/BCM/BT of Puducherry to which the Applicant belongs as mentioned in the 'Permanent Certificate of Caste/Community' shall be final and shall not be subjected to any reenquiry, unless specifically ordered by the concerned jurisdictional Subdivisional Magistrate/District Magistrate/a Court of

Law. If, any Certificate is issued incorrectly or improperly with *mala fide* intention, the official(s) responsible for its original issuance alone shall be held accountable, and appropriate legal and/or disciplinary action shall be initiated against him/her/them.

(iii) No Permanent Certificate of Caste/Community shall be issued to the Applicant who is not an ordinary resident of the Union territory of Puducherry as on the crucial date, which is mentioned in paragraph (2) applicable to his/ her Caste/Community.

(iv) No Department/Public Sector Undertaking/Agency/ Institution of the Government of Puducherry or Private Educational Institutions, which is calling for application for education (*i.e.*, for academic purposes only) in the Public/Private Educational Institutions of Puducherry, providing reservation for OBC/MBC/EBC/BCM/BT in such Educational Institutions and for availing Socio-Economic Benefits provided by various Departments of Government of Puducherry, shall insist for fresh Caste/Community Certificate in any specific format from an Applicant who is in possession of a 'Certificate of Caste/Community' issued by virtue of this Order, unless the same is specifically mandated in any specific format under any Law.

(v) Whenever an Applicant, who has obtained the 'Certificate of Caste/Community' issued by virtue of this Order, requires a fresh Caste/Community Certificate with Non-Creamy layer certification, such as OBC/MBC/EBC/BCM/BT for the purpose of employment under the Departments/Public Sector Undertakings/Institutions/Agencies of the Government of Puducherry, the Certificate issuing Authorities, in such cases, shall verify the residence status for the past five years and the creamy layer status alone and shall continue to issue the certificate in the prescribed format as in the present practice. Similarly, the OBC (Non-Creamy Layer) Certificate required for Central Government Institutions for any of the purposes shall continue to be issued in the existing present practice in the format prescribed by the Central Government/Central Government Institutions, as expeditiously as possible, in any case, not more than 5 days from the date of Application. In these cases, only creamy layer status is required to be verified, but, not the Caste/Community and ordinary residence on the crucial date/ cut-off date. Further, the temporary absence of the Applicant/Parents

for Educational/Employment purposes shall be ignored, if, his/her/their intention is to reside permanently in Puducherry and they shall continue to be treated as Residents of Puducherry. Regarding the issue of Caste/Community Certificate to the persons migrated from other States/ Union Territories, the Tahsildar/Deputy Tahsildar-*cum*-Executive Magistrate of Puducherry shall continue to issue the Caste/Community Certificate as usual, as in the present practice in the format prescribed, to a person who has migrated from another State/Union Territory, on the production of the genuine Certificate issued to his/her forefather by the prescribed Authority of the State/Union Territories, of origin except where the prescribed Authority feels that a detailed enquiry is necessary through the State of origin before issue of the Certificate.

(vi) Submission of Application: The application for the Permanent Certificate of Caste along with all necessary supporting documentary evidences shall be submitted to the Jurisdictional Taluk, Tahsildar (or) Sub-Taluk, Deputy Tahsildar-*cum*-Executive Magistrate, as the case may be, as per the Application Pro forma Annexed herewith. He/she shall be an Indian citizen. He/she or his/her forefather shall be an ordinary resident of Puducherry, as on the crucial date. The Applicant, as far as possible, shall be able to establish his/her claim through documentary evidence(s) for belonging to a Caste/Community which may fall under the OBC/MBC/EBC/BCM/BT of Puducherry.

(vii) **Processing the Application for Caste Certificate** (a) Upon receipt of an Application for issuance of a Caste Certificate, the Deputy Tahsildar-*cum*-Executive Magistrate (DT) of Sub-Taluk Office/Tahsildar of Taluk Office concerned, shall ascertain the Applicant's Caste/Community, upon verification of documentary evidences/proofs, if, any, and necessary field enquiry by the concerned Village Administrative Officer/Revenue Inspector/Deputy Tahsildar/Tahsildar and if, the Certificate Issuing Authority, *viz.*, the Tahsildar/Deputy Tahsildar requires, the list of Applicants who have applied for the Caste/Community Certificates claiming to be belonging to the OBC/MBC/EBC/BCM/BT of Puducherry, may be displayed in the form of a Notice on the Notice Board (or) at conspicuous place in the concerned Taluk/Sub-Taluk Office/

Village Administrative Officer/Revenue Inspector Office/Commune Panchayat/Municipal Office for not less than 15 days seeking objection(s), if any, from the general public. The list of Applicants shall contain only the name of the Applicant along with his/her father's name, Applicant's age, name of the caste to which he/she is claiming and residential address(es). No personally identifiable information in respect of the Applicant shall be disclosed in such Notice. If, any objection(s) is/are received, the same may be communicated to the Applicant giving him/her an opportunity to repudiate such objection and to substantiate his/her claim for belonging to such Caste/Community of Puducherry. However, the decision of the Certificate issuing Authority shall be the final and binding.

(b) The Deputy Tahsildar-*cum*-Executive Magistrate (DT)/Tahsildar shall properly scrutinize the application and if, found complete in all aspects, he shall issue the Caste/Community Certificate in the prescribed format annexed herewith, within a period of 60 working days from the date of application or shall reject the application by clearly mentioning valid reasons through a self-contained Speaking Order.

(c) Appeal against the proceedings of the Tahsildar/Deputy Tahsildar-*cum*-Executive Magistrate shall lie before the Subdivisional Magistrate-*cum*-Sub/Deputy Collector (Revenue) concerned.

(d) The Taluk Tahsildar shall maintain a Register of Caste/Community Certificates issued to OBC/MBC/EBC/BCM/BT of Puducherry with details, such as, the Certificates' serial number, date of issue, name of Caste/Community, Aadhaar Number, date of birth and address of each of the Applicant. He shall also maintain a Database of such Certificates issued in digital format, as well, and monthly update of the Database shall be forwarded to the concerned Subdivisional Magistrate for additional back-up before 5th day of the following month. It shall be preserved at the respective Taluk/Sub-Taluk offices as a permanent record in digital format for easy retrieval and also for cross-verification by various requisitioning Institutions.

(viii) **Issue of duplicate Caste Certificate** A duplicate Caste/Community Certificate in *lieu of* a lost or damaged Permanent Certificate of Caste/Community shall be issued upon application submitted along with a Non-traceable Certificate obtained from the concerned Police Authorities and an Affidavit of the Applicant detailing the facts of such matter. While issuing such Certificate, the word "DUPLICATE" shall be mentioned on the top right corner of the Certificate with the same serial number of the original Certificate.

(ix) **Validity of the Permanent Certificate of Caste:** The 'Permanent Certificate of Caste/Community' issued for Educational purposes and other Socio-Economic benefits shall be valid for the holder's lifetime unless there is a change in his/her religion and/or any other factor(s) affecting his / her eligibility to get an OBC/MBC/EBC/BCM/BT Certificate to avail reservation benefits or denotification of such Caste/Community from the list and in such eventualities, such Caste/Community Certificate which is issued shall become void. No Applicant shall reapply for a Caste/Community Certificate unless he/she has embraced other religion which also has been provided with the reservation benefits.

(x) **Offence and Cancellation of the Caste Certificate** Any Caste/Community Certificate which is obtained by using bogus documentary evidences shall be void and any effort or attempt by any Applicant to obtain such Caste Certificate by using bogus or forged documentary evidences shall constitute an offence under the Bharatiya Nyaya Sanhita, 2023, Bharatiya Nagarik Suraksha Sanhita, 2023 and/or Bharatiya Sakshya Adhiniyam, 2023 and accordingly, criminal case(s) shall be instituted against such Applicant and if, the beneficiary of such Caste/Community Certificate is a Minor, criminal case(s) shall be instituted against the Parents/Guardian who made the application on his/her behalf. Such 'Caste/Community Certificate' of permanent nature, shall be cancelled by the District Committee headed by the District Magistrate concerned as per the G.O. Ms. No. 152, dated 24-11-2005 of the Department of Revenue and Disaster Management/a Court of Law.
