2. Representation, dated 15-04-2025 received from Thiru Premkumar, Pawn Broker (L.No. 527), Muthialpet, Puducherry.

Whereas, in pursuance of the reference first cited, this Office had granted permission to Thiru B. Karthikeyan, Authorised Auctioneer to conduct the sale of unredeemed and time-barred pledged articles available with the Pawn Broker, Thiru Premkumar (L.No. 527), No. 41/43, M.G.
