#### ORDINANCE - 2

In exercise of the powers vested in Section 53(1) of the Puducherry Technological University Act, 2019, the Secretary to Government (Education)-cum-Chairman of the Governing Body of Puducherry Engineering College hereby accords approval of the Ordinance framed by the University in pursuance of Section 7(1) of the Puducherry Technological University Act, 2019 and as per Section 7 (4) of PTU (First) Statutes, 2022 for framing the Qualifications, Emoluments and Terms and Conditions of service of Registrar of Puducherry Technological University.

# QUALIFICATIONS, EMOLUMENTS, TERMS AND CONDITIONS OF SERVICE OF REGISTRAR

- 1. Registrar of the University shall be appointed on a Scale of Pay of ₹ 37400-67000, Grade Pay ₹ 10,000 (PB-4 under 6th CPC) / Pay Matrix Level : 14 (under 7th CPC).
- 2. Subject to the provisions of the PTU Act and Statutes, every Registrar of the University shall be appointed for a tenure of 3 years. The Registrar shall be eligible for reappointment for one more term only, subject to approval of the Board of Governors.
  - 3. The following shall be the qualifications and experience for the post of Registrar:
    - 3.1 Eligibility Conditions:

As per SCHEDULE - II, Section 1 (1) of PTU Act, Professor (AGP ₹ 10,000) Administrator in the rank of Professor with at least three years of administrative experience.

And

(A) Educational Qualifications:

Master's Degree with at least 55% of the marks or an equivalent grade in a point scale wherever grading system is followed.

(B) Experience:

At least 15 years of experience as Assistant Professor in the Academic Level 11 and above

OR

At least 8 years of service in the Academic Level 12 and above including as Associate Professor along with 3 years experience in Educational Administration.

OR

Comparable experience in research and development establishment and / or other institutions of higher education.

OR

At least 15 years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

4. In case of recruitment by deputation, grades from which deputation is to be made:

Persons under the Central / State Governments / Universities / Educational Institutes of higher learning / Statutory or Semi-Government / Autonomous organizations / Public Sector Undertakings, holding analogous posts in the scale and possessing Educational qualification and experience as laid down in Para 3 above.

Period of deputation shall be for a period of three years.

- 5. The Registrar shall be entitled to leave as admissible to the employees of the University from time to time.
- 6. Every Registrar shall be entitled to all admissible allowances, Travelling Allowance, Leave Travel Concession and the benefits of Medical Attendance rules as are applicable to the employees of the University from time to time.
- 7. Every Registrar shall be entitled to such retirement benefits as are admissible to the employees of the University, and shall be eligible for such other terminal benefits as may be fixed by the Board of Governors from time to time.

Provided that an employee of another University, Institution or Organisation, when appointed as Registrar, shall continue to be governed by the same retirement benefits Scheme to which he / she was entitled prior to his / her appointment as Registrar, or till he / she continues to hold lien on his / her post in such other organization.

- 8. The Registrar shall perform such other functions as may be specified in the Acts, Statutes, Ordinances and Regulations or as may be required from time to time by the Board of Governors.
- 9. The tenure of appointment and other conditions of service shall be subject to any other terms as may be prescribed by the Board of Governors.

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Government of India, Ministry of Law, Justice and Company Affairs (Department of Justice) Notification No. 30/16.76-Jus., dated 31st August, 1979 and all other enabling powers in this behalf, the Lieutenant-Governor, Puducherry, on the recommendations of the Hon'ble High Court of Judicature at Madras, is pleased to make the following rules further to amend the Puducherry Judicial Service (Cadre and Recruitment) Rules, 2008, issued *vide* Notification under G.O. Ms. No. 8/08-LD., dated 8th April, 2008 of the Law Department, Government of Puducherry and published as a Supplement to the Gazette No. 18, dated 29th April, 2008, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Puducherry Judicial Service (Cadre and Recruitment) Amendment Rules, 2025.
  - (2) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Amendment of rule 8.— (i) In the Puducherry Judicial Service (Cadre and Recruitment) Rules, 2008 (hereinafter referred to as the said rules), in Annexure-I under rule 8, for the Tabular Column at para (4), the following shall be substituted, namely:—

For the candidates belonging to Scheduled Caste and Scheduled Tribes	30 Marks
For the candidates belonging to Most Backward Classes, Other Backward Classes, Extreme Backward Classes, Backward Class Muslims and Backward Tribes.	35 Marks
For Persons with Benchmark Disabilities	28 Marks
For others	40 Marks

(ii) In the said rules, in Annexure-I under rule 8, for the Tabular Column at para (5), the following shall be substituted, namely:-

35% of Marks in each Paper	For the candidates belonging to Scheduled Caste and Scheduled Tribes
40% of Marks in each Paper	For the candidates belonging to Most Backward Classes, Other Backward Classes, Extreme Backward Classes, Backward Class Muslims and Backward Tribes
33% of Marks in each Paper	For persons with Benchmark Disabilities
45% of Marks in each Paper	For others

3. (i) In the said rules, in Annexure-II under rule 8, for the Tabular Column at para (3)(a), the following shall be substituted, namely:—

For the candidates belonging to Scheduled Caste and Scheduled Tribes	30 Marks
For the candidates belonging to Most Backward Classes, Other Backward Classes, Extreme Backward Classes, Backward Class Muslims and Backward Tribes.	35 Marks
For persons with Benchmark Disabilities	28 Marks
For others	40 Marks

(ii) In the said rules, in Annexure-II under rule 8, for the Tabular Column at para (3)(b), the following shall be substituted, namely:—

30% of Marks in each Paper	For the candidates belonging to Scheduled Caste and Scheduled Tribes
35% of Marks in each Paper	For the candidates belonging to Most Backward Classes, Other Backward Classes, Extreme Backward Classes, Backward Class Muslims and Backward Tribes
28% of Marks in each Paper	For persons with Benchmark Disabilities
40% of Marks in each Paper	For others
