புதுச்சேரி மாவட்டம், பாகூர் தாலுக்கா, 77 - இருளன்சந்தை வருவாய் கிராமத்தில் R.S. No. 23/8pt.-இல் 00.02.13 ஹெக்டேர் மற்றும் R.S. No. 45/2pt.-இல் 00.38.02 ஹெக்டேர் என மொத்தமாக 00.40.15 ஹெக்டேர் பரப்பளவுள்ள நிலங்கள் “நிலமற்ற ஆதிதிராவிடர், பழங்குடியினர் மற்றும் பிற பின்தங்கிய பிரிவினை சேர்ந்த ஏழைகளுக்கு இலவச வீட்டுமனை வழங்குவது”, என்ற பொது நோக்கத்திற்காக தேவைப்படுகிறது என புதுச்சேரி அரசு கருதுகிறது. அதற்காக, சமுதாய தாக்க கணிப்பு அமைப்பால் (SIA Unit) சமுதாய தாக்க மதிப்பீட்டு ஆய்வு செய்யப்பட்டது. 2013-ஆம் ஆண்டு நிலம் கையகப்படுத்துதல், மறுவாழ்வளிப்பு மற்றும் மறுகுடியமர்வில் நியாயமான இழப்பீடு மற்றும் வெளிப்படைத்தன்மை உரிமை சட்டத்தின் 4-ஆம் பிரிவின் கீழ் உரைக்கப்பட்டவாறு சிறப்பு அரசு செயலர் (வருவாய்) அவர்களால் அமைக்கப்பட்ட ஒரு குழுவால் முதனிலை ஆய்வு செய்யப்பட்டது / அறிக்கை ஒன்று சமர்ப்பிக்கப்பட்டது. இந்த சமுதாய தாக்க கணிப்பு அறிக்கையானது ஏற்கனவே வெளியிடப்பட்டுள்ளது.

Whereas, the Government is of the opinion that lands to an extent of 00.02.13 H.A.C. at R.S.No. 23/8pt., and to an extent of 00.38.02 H.A.C. at R.S.No. 45/2pt., measuring to a total extent of 00.40.15 H.A.C. in Irulansanthai Revenue Village of Bahour Taluk, Puducherry are required for the public purpose viz., "For provision of free house sites to poor landless SC/ST/OEBC people". The Social Impact Assessment (SIA Unit) study was carried out by the Social Impact Assessment Unit and a preliminary investigation was conducted/report submitted by a team constituted by the Special Secretary (Revenue) as laid down under section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. The Social Impact Assessment report was already published.

And whereas, the Sub/Deputy Collector (Revenue) South, Villianur, is appointed as the Administrator for preparation of Rehabilitation and Resettlement Scheme of the affected families and therefore, it is notified that for the abovesaid project, an extent of 00.02.13 H.A.C. at R.S.No. 23/8pt., and to an extent of 00.38.02 H.A.C. at R.S.No. 45/2pt., measuring to a total extent of 00.40.15 H.A.C. in Irulansanthai Revenue Village of Bahour Taluk, Puducherry are under acquisition, the detailed description of which is as follows:-

## ANNEXURE

**Standing Order Prescribing Procedures/Standards for Conducting Physical Standards Test, Physical Endurance Test, Written Test and Medical Examination, etc., for Direct Recruitment/Promotion as Sub-Inspector of Police (Male) in India Reserve Battalion, Puducherry**

1. *Constitution of Recruitment Committee.*— A Recruitment Committee, as constituted by the orders of the Head of Department, would oversee the entire recruitment process.

2. *Physical Standards Test (PST)*—

Physical Standards	Eligibility Conditions
Height	Not less than 167 cms.
Chest	81-86 cms. (with minimum expansion of 5 cms.)
Weight	Body Mass Index (BMI) should be 18.50 to 29.9 kg/m <sup>2</sup>

Physical measurements as prescribed in the eligibility conditions of the candidates will be done by the experts provided by the Government under the overall supervision of the Recruitment Committee, as constituted by the orders of the Head of Department.

3. *Appeal.*— The appeal made by any candidate will be examined and the decision of the Chairman of the Appeal Board as constituted by the orders of the Head of Department in respect of the appeals shall be the final.

4. *Physical Endurance Test (PET) (only for Direct Recruits).*— All candidates who qualify the Physical Standards Test shall undergo Physical Endurance Test.

Stages	Events	Minimum standard to acquire
Stage-I	100 metres run	15.00 seconds
Stage-II	Long jump	3.80 metres
Stage-III	High jump	1.20 metres
Stage-IV	800 metres run	2 minutes and 50 seconds

*All the above events are compulsory*

Each stage is a qualifying stage by itself for the next stage, *i.e.*, only the candidates who qualify in Stage-I, will be eligible for Stage-II and so on.

Ex-Servicemen will not be required to pass Physical Endurance Test. They will be eligible to appear for the written test, if, they possess the minimum Physical Measurements/Standards.

5. *Procedure.*—

(i) The testing procedure, time and venue would be decided and subject to change by the Chairman, Recruitment Committee, as constituted by the orders of the Head of Department as and when the necessity arises.

(ii) To ensure accuracy and tamper-proof conduct of running events, Radio Frequency Identification (RFID) chip timing technology shall be used.

(iii) Standard digital height/weight devices with display monitors would be used for measuring height and weight. The same should be certified by Government agencies like BIS, *etc.*

(iv) CCTV would be used to record all stages of Physical Standards Test/Physical Endurance Test.

6. *Written Test.*— All candidates who qualify in Physical Standards Test and Physical Endurance Test shall undergo a Written Test. The syllabus, *etc.*, will be notified while advertising the posts for recruitment.

7. *Medical Examination.*— All candidates who qualify the Physical Standards Test, Physical Endurance Test and Written Test shall undergo medical examination. The medical examination shall be conducted by various Specialists in designated Government Hospitals.

MEDICAL STANDARDS TO BE MET

**(a) Eye sight**

*Distant vision* : I. Normal – Both eyes should be 6/6

(OR)

(1) Better eye with correction 6/6

(2) Worse eye vision 6/12 (without correction)

(OR)

Both eyes should be 6/9

*Near Vision* : Normal - Both eyes should be JI

(OR)

Better eye with correction JI and worse eye without correction JII.

II. Free from colour blindness.

- (b) Hearing** : Free from any disability.
- (c) Defects or deformity** : Free from any defect or deformity of limbs.
- (d) Disease** : Free from hernia, piles, respiratory disease, diabetes or any other disease, which will adversely affect the work of Sub-Inspector of Police (Male) (IRBn).
- (e) Other** : Should not be flat-footed or suffering from knocked-knees or bowed legs and should not be obese (BMI should not be more than  $29.9 \text{ kg/m}^2$ ).

8. *Training and Probation (for direct recruits).*— (i) The candidates, who have been selected for the post of Sub-Inspector of Police (Male), IRBn, will remain on probation for a period of 2 years. They shall undergo a Basic Training for one year in any of the Police/CAPF Training Centres in India and Phase-II Training as per raising guidelines of IRBn. The progress of training will be assessed through periodic exams.

(ii) During the period of probation, if, it is found that the performance of trainee is unsatisfactory, suitable action including his discharge from the service, will be taken under the Rules.

9. *Training (for promotees).*— (i) Those candidates who are selected by the Departmental Promotion Committee for promotion to the post of Sub-Inspector of Police (Male) have to undergo a capsule training course for 3 months. Provided that those who have completed 55 years of age on the date of promotion will not be required to undergo physical training.

(ii) All candidates should complete this successfully, failing which the training period would be extended once. Till the promotee successfully complete the training, completion of probation will not be declared in the post of Sub-Inspector of Police (Male), IRBn.
