The Petroleum Pump Dealers are hereby informed that the seized 5800 litres of diesel in Crime No. 03/2024 of the Food Cell Police Station. The same will be disposed off in as-is-where-is condition by auction on 18-02-2025 at 11.00 a.m.

Terms and Conditions

1. The sealed covers should be addressed to the Superintendent of Police, Food Cell Police Station, duly superscribing on the envelope as "Auction for purchase of diesel" should reach the Office of the Inspector of Police, Mahe Circle, Mahe on or before 5.00 p.m. on 17-02-2025. The sealed covers will be opened at 11.00 a.m. on 18-02-2025 in the presence of tenderers present if any, in the Office of the Circle Inspector of Police, Mahe Police Station Complex, Mahe Main Road, Mahe-673 310 (rate quote per litre for each seized items of diesel separately if any variation).

2. The diesel auctioned would be awarded to the highest bidder on the spot.

3. The intending bidders should deposit an earnest money deposit of ₹ 500 (Rupees five hundred only) Demand Draft to be drawn in favour of "The Superintendent of Police, Food Cell Police Station, Puducherry" along with sealed bid. The earnest money deposit of the unsuccessful tenderers will be refunded on the same day soon after completion of auction.

4. The successful bidder should pay the entire amount soon after the completion of the auction and should clear the auctioned diesel at his/her own arrangement/cost before 5.00 p.m. on the same day, failing which the Station will not be held responsible either for the safe custody or loss or damage of items once the auction is over.

5. GST/Sales tax will be charged extra as per the rate applicable, at the time of tender sale.
6. No claim on the quantity or quality of the items will be admitted once the tender sale is over.
7. The intending bidders can inspect the items of seized diesel during the office hours on any working day but, on or before the auction date at this Food Cell Police Station with the permission of the undersigned.
8. The bids offered after the due date and time will be rejected.
9. The undersigned reserves the right to accept or reject any or all bidders without assigning any reason thereof. If, the auction date falls on a public holiday, the auction will be held on the next working day.
10. Auction is subjected to the discretion of the undersigned whose decision will be the final in case of any dispute.
