2. The functions of the Consultative Committee are as follows:

- (i) To present the fiscal situation of the financial year
- (ii) To focus on matters of economic development
- (iii) To suggest Ways and Means to augment Union Territory's own resources.

3. Pre-Budget Stakeholder Consultation meeting of the Committee Members will be convened once in a year. The Non-official Members of the Committee are entitled to draw TA/DA for attending the meeting of the Committee as applicable to Government Officials drawing Grade Pay of ₹ 7,600 (Level 12 as per 7th CPC).

4. The expenditure will be met under the head 3451-Secretariat Economic Services-102-District Planning Machinery-102(01)-State Planning Machinery-102(01)(01)-Puducherry region – 13-Office Expenses.
