**ORDER**

Adverting to the Orders, dated 30-06-2023 of the Hon'ble High Court of Judicature at Madras in W.P. Nos.: 34726 of 2022 and 3241 of 2023 and G.O. Ms. No. 1/CHRI/T.2/2023, dated 14-07-2023 and in exercise of the powers conferred under the Puducherry Hindu Religious Institutions Act, 1972, Thiru K. Sithanandan, s/o. Kaliyamoorthy, Driver Gr.-I Government General Hospital, Karaikal, Puducherry, is hereby appointed as Temple Administrative Officer of Arulmigu Mariamman and Iyyanar Temple, Odudhurai, Neravy Commune Karaikal, Puducherry, on honorary basis. The Temple Administrative Officer shall administer the said Devasthanam as envisaged in the provisions of the Puducherry Hindu Religious Institutions Act, 1972 and the rules framed thereunder:

***Important duties and responsibilities of the Temple Administrative Officer are given below***

- (i) To take over the administration of the said Devasthanam along with movable and immovable assets;
- (ii) Submission of compliance report on taking over of the administration of the temple along with the details of movable and immovable properties with a period of fifteen days from taking over the administration;
- (iii) Submission of annual report on maintenance of movable and immovable assets including the cleaning and desilting of temple ponds;
- (iv) To coordinate and facilitate the completion of work undertaken by donors as per rule 13 (9);
- (v) Submission of annual budget by March as per rule 13 of the Act;

(vi) To maintain accounts as per sections 14 to 17 of Hindu Religious Institutions Act and to get the accounts audited annually by the Directorate of Accounts and Treasuries, Puducherry;

(vii) Shall ensure that the Poojas and Festivals are conducted according to the customs followed by the Devasthanam;

(viii) Shall collect all debts and funds due to the Institution and secure them from the loss or risk of loss;

(ix) Shall ensure that appropriate proceedings are instituted to effect all debts and funds due to the institution or recovery thereof and also to defund such action against the institution in respect of the property of the institution;

(x) Shall not connive at or facilitate any act or conduct of another person which would involve a breach of trust or occasion risk or loss to the property belonging to the Institution;

(xi) Shall strictly conform to and carry out the terms and shall not encumber the properties of the Institution by persistently incurring expenditure beyond the limits of the income of the property of the Institution;

(xii) Shall not in any way make use of the property of the Institution or of his position as Temple Administrative Officer, for his self-interest or private advantage; and shall be personally responsible for the exercise of his judgment and for performance of his duty and he cannot, therefore, escape responsibility by leaving to another person the exercise of judgment or the performance of that duty.

The Temple Administrative Officer shall hold office for a period of three years from the date of its appointment, unless in the meanwhile removed or dismissed or on resignation is accepted or otherwise cease to be Temple Administrative Officer.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 13 of the Puducherry Motor Vehicles Taxation Act, 1967 (Act No. 5 of 1967) and in pursuance of the Notification *vide* G.S.R. 720(E), dated 05-10-2021 of the Ministry of Road Transport and Highways, New Delhi and the Notification *vide* G.O. Ms. No. 01/Tr.Sectt./2024, dated 05-01-2024 of the Transport Secretariat, Government of Puducherry, the approval of the Lieutenant-Governor, Puducherry, is hereby conveyed for the grant of "Concession in Motor Vehicle Tax" to the vehicles registered against the submission of "Certificate of Deposit (CoD)" issued by the "Registered Vehicle Scrapping Facility (RVSF)", in the Union territory of Puducherry, which shall be as follows:

- (i) Non-Transport Vehicle (a) The tax concession for the newly registered two and three wheeled motor vehicle against submission of "Certificate of Deposit" issued by the "Registered Vehicle Scrapping Facility" shall be equivalent to 25% of tax payable.
- (b) The tax concession for the four wheeled motor vehicle shall be equivalent to 25% of tax payable or ₹ 11,000, whichever is less.

*Note* : For availing of the concession in Motor Vehicle Tax, the "Certificate of Deposit" of same or higher class of vehicle shall be submitted as detailed below :

- (i) For two wheeler, CoD obtained for two or three or four wheeled motor vehicle shall be submitted.
- (ii) For three wheeler, the CoD obtained for three or four wheeled motor vehicle shall be submitted.

- (iii) For four wheeler, CoD obtained for four wheeled motor vehicle of LMV or MMV or HMV, as the case may be or higher class of vehicle shall be submitted.

- (ii) Transport Vehicle The tax concession for the newly registered vehicle against submission of "Certificate of Deposit" issued by the "Registered Vehicle Scrapping Facility" shall be equivalent to 15% of tax payable for a period of 8 years, from the date of registration.

*Note* : The tax concessions shall be against CoD obtained irrespective of age of vehicle.

2. This Notification shall be deemed to have come into force with effect from 01-04-2024 and shall be valid for a period of five years. The above "Concession in Motor Vehicle Tax" shall be subject to the conditions as stipulated in the 'Puducherry Motor Vehicle Scrapping Policy, 2024' read with the amendments made thereunder or any Orders/Guidelines issued by the Government, from time to time.
