ORDER

The Ministry of Housing and Urban Affairs, Government of India, has launched the Pradhan Mantri Awas Yojana - Urban 2.0 (PMAY-U 2.0) - 'Housing for All' Scheme to provide Central Assistance to all eligible beneficiaries/households/implementing agencies through States/Union Territories (UTs)/Primary Lending Institutions (PLIs) to construct, purchase or rent a house at an affordable cost. A Memorandum of Agreement has been signed between the Ministry of Housing and Urban Affairs, Government of India and the Government of Puducherry on 08-11-2024 in order to participate in the Scheme and to avail financial assistance from Central Government. As per Scheme guidelines, States/UTs are required to constitute various Committees for implementation of the PMAY-U 2.0. Accordingly, the Government is pleased to constitute a State Level Sanctioning and Monitoring Committee (SLSMC) with the following composition:

2. The abovesaid Committee will be the State Level Sanctioning and Monitoring Committee for both the Pradhan Mantri Awas Yojana (Urban) Scheme and also the newly launched Centrally Sponsored Scheme of "Pradhan Mantri Awas Yojana (PMAY) (Urban) 2.0 Scheme". In addition to the functions assigned for the Pradhan Mantri Awas Yojana (Urban) Scheme. G.O. Ms. No. 33/2015-Hg., dated 6-10-2015 of the Chief Secretariat (Housing), the functions of the State Level Sanctioning and Monitoring Committee in respect of the PMAY (Urban) 2.0 Scheme shall be as follows:

- (a) Approval of DPRs under the components of Affordable Housing in Partnership and Affordable Rental Housing, Approval of Project details of Beneficiary Led Construction along with list of beneficiaries under the Mission.
- (b) Approval of Annual Quality Monitoring Plans.
- (c) Reviewing progress of approved projects.
- (d) Monitoring of overall implementation of Mission.
- (e) Approval of Annual Capacity Building Plans.
- (f) Any other issues required for effective implementation of the Mission.
- (g) Appraisal/Approval of Action Taken Reports on Third Party Quality Monitoring Agency and Social Audit.

3. Further, the Government is pleased to designate the Secretary to Government (Town and Country Planning Department) as the State Mission Director and to designate the Town and Country Planning Department as the State Level Nodal Agency for the newly launched Centrally Sponsored Scheme of "PMAY (Urban) 2.0 Scheme". The Town and Country Planning Department shall open a Single Nodal Account (SNA) in the Bank which can function with SNA-SPARSH system. The Town and Country Planning Department shall *ad here* to the conditions stipulated by the Department of Expenditure, Ministry of Finance in maintaining the Single Nodal Account for the Centrally Sponsored Schemes.

4. The Government is also pleased to notify that the State Level Appraisal Committee, constituted *vide* G.O. Ms. No. 20/2016-Hg., dated 02-11-2016 of the Chief Secretariat (Housing), shall also function as the State Level Appraisal Committee for the PMAY (Urban) 2.0 Scheme.

5. In order to finalize the beneficiaries for various components of the PMAY (Urban) 2.0 Scheme, the Government is pleased to constitute "Regional Level Committee for finalization of the beneficiaries under PMAY (Urban) 2.0 Scheme" with the following composition:

6. The powers and functions of the "Regional Level Committee for finalization of the beneficiaries under PMAY (Urban) 2.0 Scheme" shall be as follows:

(a) Finalization of beneficiaries, as shortlisted by the respective Implementing Agencies as per the guidelines of the PMAY (Urban) 2.0 Scheme.

(b) Monitoring progress of approved projects in their respective regions.

(c) The Chairman, Regional Level Committee may co-opt other Members for the said Committee as per the requirements.

(d) The Regional Level Committee may also inspect the site/beneficiary house to ascertain the details of the prospective beneficiaries.

(e) The Regional Level Committee may also direct the State Level Nodal Agency or any other agency to conduct site verification to ascertain the details given by the prospective beneficiaries before finalization of the Scheme.

7. The State Level Sanctioning and Monitoring Committee, State Level Appraisal Committee and the Regional Level Committee shall meet often or as and when it is necessary.
