ORDER

Pursuant to the directions of the Hon'ble Supreme Court of India in W.P.(Civil) No. 83 of 2010 and *vide* Letter in R.O.C.No. 57694-A/2025-B2, dated 24-06-2025 of the Hon'ble Registrar-General, High Court of Judicature at Madras, a Committee is constituted to identify the State Laws, Regulations, Statutory Rules or Bye-Laws, where the discriminatory expressions in respect of Leprosy affected or cured persons are still part of the Statute book, with the following composition, namely:-

- (i) Tmt. M.D. Sumathi, . . Chairperson
District Judge,
now functioning as Sessions Judge,
Fast Track Court exclusively to
deal with offences under the
POCSO Act, Puducherry.
- (ii) Tmt. Jhanaz Raffi *alias* Jhansi, . . Member
Under Secretary (Law),
Law Department,
Government of Puducherry.
- (iii) Thiru S. Dhanaraj, . . Member
Law Officer,
Union Territory of Puducherry
Legal Services Authority (UTPLSA),
Government of Puducherry.

2. The Committee shall identify : (i) all the State Laws, pre or post Constitution where the discriminatory expressions in respect of leprosy affected or cured persons are still part of the statute book, (ii) such Regulations, Statutory Rules or Bye-Laws where similar provisions have been incorporated, shall also be identified. This exercise shall further include the Regulations formulated under different Statutes, Service Rules enacted under proviso to Article 309 of the Constitution as well as Bye-Laws framed under different Statutes like Co-operative Societies Act.

3. The Committee shall thereafter make recommendations to the Government for suitable amendment in all the Statutes, Regulations, Rules, Bye-Laws or Instructions and also to take necessary initiatives and bring the Laws strictly in conformity with the Constitutional commitments and principles. The Committee shall also forward the report to the Secretary General of the Hon'ble Supreme Court of India.
