[2013-ஆம் ஆண்டு நிலம் கையகப்படுத்துதல், மறுவாழ்வளிப்பு மற்றும் மறுகுடியமர்வில் நேரிய சரியீடு மற்றும் வெளிப்படைத்தன்மை உரிமைசட்டத்தின், 11-ஆம் பிரிவை சேர்ந்த (1) உட்பிரிவின் கீழ்]

புதுச்சேரி மாவட்டம், உழவர்கரை வட்டம், 35 - உழவர்கரை வருவாய் கிராமத்தில் 00.06.90 ஹெக்டேர் பரப்பளவுள்ள நிலங்களை, “குடும்பாபேட வீட்டு வசதி வாரியத்தில் இருந்து பிச்சைவீரன்பேட வரை கால்வாய் அமைப்பது” என்ற பொது நோக்கத்திற்காக தேவைப்படுகிறது என புதுச்சேரி அரசு கருதுகிறது. அதற்காக, சமுதாய தாக்கக் கணிப்பு அமைப்பால் (SIA Unit) சமுதாய தாக்க மதிப்பீட்டு ஆய்வு செய்யப்பட்டது. நிலம் கையகப்படுத்துதல், மறுவாழ்வளிப்பு மற்றும் மறுகுடியமர்வில் நேரிய சரியீடு மற்றும் வெளிப்படைத்தன்மை உரிமை சட்டத்தின் 4-ஆம் பிரிவின் கீழ் உரைக்கப்பட்டவாறு சிறப்பு செயலர் (வருவாய்) அவர்களால் அமைக்கப்பட்ட ஒரு குழுவால் முதனிலை ஆய்வு செய்யப்பட்டது/அறிக்கை ஒன்று சமர்ப்பிக்கப்பட்டது. இந்த சமுதாய தாக்க கணிப்பு அறிவிக்கையானது ஏற்கனவே வெளியிடப்பட்டுள்ளது.

2. பாதிக்கப்பட்ட குடும்பங்களின் மறுவாழ்வளிப்பு மற்றும் மறுகுடியமர்வு திட்டத்திற்காக சார்பு/துணை ஆட்சியர் (வருவாய்) வடக்கு, புதுச்சேரி, அவர்கள் நிர்வாகியாக பணியமர்த்தப்பட்டுள்ளார். ஆதலால், புதுச்சேரி மாவட்டத்தின், 35 - உழவர்கரை வருவாய் கிராமத்தில் 00.06.90 ஹெக்டேர் பரப்பளவுள்ள நிலத்தினை மேற்குறிப்பிட்ட நோக்கத்திற்காக கையகப்படுத்தலின் கீழ் இருக்கிறது. அதன் விளக்கமான விவரிப்பு பின் வருமாறு:-

Whereas, the Government is of the opinion that an extent of 00.06.90 H.A.C land at 35 - Oulgaret Revenue Village of Puducherry District, is required for the public purpose viz., "Construction of Masonary Drain from Kurumbapet Housing Board to Pitchaiveeranpet, Puducherry". The Social Impact Assessment (SIA) Study was carried out by the Social Impact Assessment Unit and a preliminary investigation was conducted / report submitted by a team constituted by the Special Secretary (Revenue) as laid down under section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. The Social Impact Assessment report was already published.

2. And whereas, The Sub / Deputy Collector (Revenue) North, Puducherry, is appointed as the Administrator for preparation of Rehabilitation and Resettlement Scheme of the affected families and therefore, it is notified that for the abovesaid project in 35 - Oulgaret Revenue Village of Puducherry District, the land measuring an extent of 00.06.90 H.A.C is under acquisition, the detailed description of which is as follows:-
