#### NOTIFICATION

In exercise of the powers conferred under section 4(f) of the Bharatiya Nyaya Sanhita, 2023 (Act No. 45 of 2023), read with the relevant sections of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act No. 46 of 2023), the High Court of Judicature at Madras hereby makes the following Guidelines for award of community service as punishment, namely:
