**NOTIFICATION**

Ms. No. 44/2005/Wel(SW-V), dated 06-10-2005 of the Under Secretary to Government (Welfare), Puducherry, (3) G.O. Ms. No. 4/DSW/2013-14, dated 30-01-2014 of the Under Secretary to Government

(Social Welfare), Puducherry, (4) G.O. Ms. No. 17/SWS/2019-20, dated 16-09-2019 of the Under Secretary to Government (Social Welfare), Puducherry and (5) G.O. Ms. No. 02/SWS/2022-23, dated 25-04-2022 of the Under Secretary to Government (Social Welfare), Puducherry, for the enhancement of financial assistance towards funeral expenses as follows:

#### AMENDMENT

In the said rules, in sub-rule(1) of rule 8, G.O. Ms. No. 02/SWS/2022-23, dated 25-04-2022 of the Under Secretary to Government (Social Welfare), Puducherry, for the letters and figures “₹ 15,000” thereof, the letters and figures “₹ 25,000” shall be substituted.

2. The enhanced rate of funeral expenses shall effect from the date of issue of this Order.
