Whereas, an application, dated 03-01-2025 was received from Thiru Manish Kumar Sethi, No. 288, Kosa Kadai Street, Puducherry, a licensed Pawn Broker (L.No. 440) requesting permission of the District Magistrate to sell unredeemed and time barred articles in public auction;

2. And whereas, the list of unredeemed and time barred articles submitted by the Pawn Broker was forwarded to the Sub-Collector (Revenue) - North, Puducherry, for causing physical verification of the articles and ascertain that they remain unredeemed after the time allowed for redemption;

3.
