ANNEXURE

**Standing Order Prescribing Procedures/Standards for Conducting Physical Measurement,
Physical Endurance Test, Written Test and Medical Examination for the Direct Recruitment of
Sub-Inspectors/Promotion of Sub-Inspectors in Puducherry Police**

1. *Constitution of Recruitment Committee.*— A Recruitment Committee, as constituted by the orders of the Head of Department, would oversee the entire recruitment process.

2. *Physical Measurements—*

Physical Standards

ELIGIBILITY CONDITIONS

	Men	Women
Height	Not less than 165 cms.	Not less than 154 cms.
Chest	81-86 cms., with minimum expansion of 5 cms.	—
Weight	Body Mass Index (BMI) should be 18.50 to 29.9 kg/m ² .	45 kgs. minimum

Physical measurement as prescribed in the eligibility conditions of the candidates will be done by the experts provided by the Government under the overall supervision of the Recruitment Committee, as constituted by the orders of the Head of Department.

3. *Appeal.*— The appeal made by any candidate will be examined and the decision of the Chairman of the Appeal Board as constituted by the orders of the Head of Department in respect of the appeals shall be the final.

4. *Physical Endurance Test (Only For Direct Recruits).*— All candidates (male and female) who qualify the Physical Standards Test shall undergo Physical Endurance Test.

For Male candidates

Stages	Events	Minimum standard to acquire
Stage-I	100 metres run	15.00 seconds
Stage-II	Long jump	3.80 metres
Stage-III	High jump	1.20 metres
Stage-IV	800 metres run	2 minutes and 50 seconds

All the above events are compulsory.

For Female candidates

Stages	Events	Minimum standard to acquire
Stage-I	100 metres run	16.50 seconds
Stage-II	Long jump	3.25 metres
Stage-III	High jump	1.05 metres
Stage-IV	200 metres run	36.00 seconds

All the above events are compulsory.

Each stage is a qualifying stage by itself for the next stage, *i.e.*, only the candidate who qualifies in the Stage-I will be eligible for the Stage-II, and so on.

(*) Ex-Serviceman will not be required to pass Physical Endurance Test. They will be eligible to appear for the written test if, they possess the minimum physical Measurements.

5. *Procedure.*—

(1) The testing procedure, time and venue would be decided and subject to change by the Chairman, Recruitment Committee, as constituted by the orders of the Head of Department as and when the necessity arises.

(2) To ensure accuracy and tamper-proof conduct of running events Radio Frequency Identification (RFID) chip timing technology shall be used.

(3) Standard digital height/weight devices with display monitors would be used for measuring height and weight. The same should be certified by Government agencies like BIS, *etc.*

(4) CCTV would be used to record all stages of PST/PET.

6. *Written Test.*— (i) All candidates (male and female) shall undergo a written test. The questions will be of objective type and of graduation level. The question paper will be in two parts, each of 100 questions and two hours duration, consisting of:—

(ii) The question paper will be bi-lingual, *i.e.*, in English and in any one of the regional languages, *viz.*, Tamil/Malayalam/Telugu. However, questions in respect of English language, Literature, Grammar and Comprehension (Sl. No. D of Paper-I mentioned above) will be only in English.

(iii) Both papers are compulsory.

(iv) Selection will be based on the marks obtained in the Written Test. There will be no interview.

7. *Minimum Qualifying Marks.*— A candidate must appear in both Paper-I and Paper-II compulsorily and secure the minimum qualifying marks in both the papers as mentioned below—

UR	:	30%
OBC/MBC/EBC/BCM/BT/EWS	:	25%
SC/ST	:	20%

Provisional Select list will be drawn based on the marks obtained by the applicants in the competitive examination, subject to reservation as per rules in force.

8. *Medical Examination.*— All candidates (male and female) who qualify the Physical Standards, Physical Endurance and Written Tests shall undergo medical examination. The medical examination shall be conducted by various Specialists in designated Government Hospitals.

MEDICAL STANDARDS TO BE MET

(a) Eye sight

Distant vision : I. Normal – Both eyes should be 6/6

(OR)

(1) Better eye with correction 6/6

(2) Worse eye vision 6/12 (without correction)

(OR)

Both eyes should be 6/9

Near Vision : Normal - Both eyes should be JI

(OR)

Better eye with correction JI and worse eye without correction JII.

II. Free from colour blindness.

(b) **Hearing** : Free from any disability.

(c) **Defects or deformity** : Free from any defect or deformity of limbs.

(d) **Disease** : Free from hernia, piles, respiratory disease, diabetes or any other disease, which will adversely affect the work of Sub-Inspector of Police.

(e) **Other** : Should not be flat footed or suffering from knocked-knees or bowed legs and should not be obese (BMI more than 29.9 kg/m²).

9. *Relaxation for candidates belonging to SC/ST/OBC/MBC/EBC/BCM/BT/EWS.*— In case, requisite number of SC/ST/OBC/MBC/EBC/BCM/BT/EWS candidates do not qualify in the select list up to the seats reserved for them, the Recruitment Committee, as constituted by the orders of the Head of Department will have full discretion to recommend SC/ST/OBC/MBC/EBC/BCM/BT/EWS candidates who get next lower rank place in the Test except where such authority considers that the minimum standard necessary for the maintenance of efficiency of the Administration, has not been reached.

10. *Final list of selected candidates.*— The final list will be declared separately for General Candidates, SC/ST/OBC/MBE/BCM/BT/EWS as per the Government orders in force.

11. (a) **Training and Probation (for direct recruitee)**

(i) The candidates who have been selected for the post of Sub-Inspector of Police will remain on probation for a period of 2 years. They shall undergo a Basic Training Course for one year. The progress of training will be assessed through periodic exams.

(ii) During the period of probation if, it is found that the performance of trainees is unsatisfactory, suitable action including his discharge from the service will be taken under the Rules.

(b) **Training and Probation (for promotee)**

(i) Those candidates who are selected by the PEB for promotion to the post of Sub-Inspector of Police have to undergo a capsule training course for 3 months. Provided that those who have completed 55 years of age on the date of promotion will not be required to undergo physical training.

(ii) All candidates should complete this successfully, failing which the training period would be extended once. Till the promotees successfully complete the training, completion of probation will be not be declared in the post of Sub-Inspector of Police.

Note : This supersedes all Standing Orders issued in this regard previously.
