NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to approve the proposal for enhancement of Financial Assistance of Old Aged Fishers in the Union territory of Puducherry and for the said purpose, hereby further amends the "Old Age Pension for Fishermen Rules, 2003" issued vide notification under G.O. Ms. No. 13/Fy., dated 11-12-2003 of the Department of Rural Development, Chief Secretariat (Fisheries), Puducherry (hereinafter referred to as the said rules) as follows:-

1. *Short title and commencement.*— (1) These rules may be called the “Old Age Pension for Fishermen (Amendment) Rules, 2025”.

(2) They shall come into force with effect from the date of their notification in the Official Gazette.

2. *Amendment of Rule 7.*— In the said rules, in sub-rule (1) of rule 7, under the heading “Quantum of assistance and sanction” the following shall be substituted, namely:-

Sl. No.	Age group	Existing Quantum of assistance per month	Enhanced Quantum of assistance per month

1.	Age group of 50-59 years.	₹ 2,500 (Rupees two thousand and five hundred only).	No change
2.	Age group of 60-69 years.	₹ 3,000 (Rupees three thousand only).	No change
3.	Age group of 70-79 years.	₹ 3,000 (Rupees three thousand only).	₹ 3,500 (Rupees three thousand and five hundred only).
4.	Age group of above 80 years.	₹ 4,000 (Rupees four thousand only).	No change
