And whereas, it has been proposed to enhance the pension benefits from \gtrless 10,000 per month to \gtrless 15,000 per month to the Media Persons in the Union territory of Puducherry based on the assurance made by the Hon'ble Chief Minister on the Floor of Puducherry Legislative Assembly during the 5th session of the 15th Legislative Assembly, dated 13-08-2024.

Now, therefore, the Lieutenant-Governor, Puducherry, is pleased to approve the said proposal and for the said purpose hereby makes further Amendment to the Scheme for the Grant of Pension Benefits to the Media Persons in the Union territory of Puducherry namely:

AMENDMENT

1. Short title.— This Scheme may be called "Scheme for the Grant of Pension Benefits to the Media Persons in the Union territory of Puducherry (Amendment) 2025".

2. Amendment in Clause 5.— In clause 5 of the Scheme for the Grant of Pension Benefits to the Media Persons in the Union territory of Puducherry for the words and figures "₹ 10,000 (Rupees ten thousand only)" the words and figures "₹ 15,000 (Rupees fifteen thousand only)" shall be substituted.

3. *Effect of Amendment.*— This Amendment shall come into force with effect from March 2025.
