NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to approve the following Amendment for the pattern of assistance under the Scheme "Welfare and Relief for Fishermen during Lean Seasons and Natural Calamities, 2023" for implementation in the Union territory of Puducherry previously notified *vide* G.O. Ms. No. 09/Fy., dated 23-03-2023 of the Chief Secretariat (Fisheries), Puducherry and published in the Extraordinary Gazette of Puducherry, Part-II, No. 31, dated 30th March, 2023 (hereinafter referred to as the said rules) namely:-

[Part-II

1. Short title, extent and commencement.— (i) This Scheme may be called the "Welfare and Relief for Fishermen during Lean Seasons and Natural Calamities (Amendment) Scheme, 2025".

(ii) It shall extend to the whole of the Union territory of Puducherry.

(iii) It shall come into force with effect from the date of its publication in the Official Gazette.

II. AMENDMENT

1. Amendment of Clause 9.— In the said Scheme, under Schedule-2 of Clause 9, under the heading "Pattern of Assistance" the following shall be substituted, namely:-

"9. *Pattern of Assistance.*— Lean Season Assistance : Financial assistance @ ₹ 6,000 (Rupees six thousand only) per fishermen family during monsoon season of every year/natural calamities shall be paid as 'Lean Relief' through ECS.

(ii) Fishing Ban Period Assistance: Financial assistance of ₹4,000 (Rupees four thousand only) per fishermen family as ban relief for 47 days of fishing ban period or ₹8,000 (Rupees eight thousand only) per fishermen family shall be paid as 'Ban Relief' in case of 61 days of fishing ban through ECS as the case may be."
