NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to make the following further Amendments to the “The Rules for the Grant of Incentive for the marriage between Disabled and Normal Persons, 1986” which was originally notified *vide* G.O. Ms. No. 27/86-Wel(HSW), dated 30-04-1986 and published in Part-II of the Extraordinary Gazette, dated 15th October, 1986 and amended short title of the rules name as “The Rules for Grant of Financial Assistance for the marriage between differently abled and normal persons and between the differently abled persons, 2012” *vide* G.O. Ms. No. 54/2012-Wel(SW-V), dated 27-02-2012, namely:—

AMENDMENT

In the said rules, in rule 6 :

I. In clause (a), for the words and figures “₹ 1,00,000 (Rupees one lakh only)”, the words and figures “₹ 1,50,000 (Rupees one lakh fifty thousand only)” shall be substituted.

II. In clause (b) :

(i) For the words and figures “₹ 20,000 (Rupees twenty thousand only)”, the words and figures “₹30,000 (Rupees thirty thousand only)” shall be substituted.

(ii) For the words and figures “₹ 80,000 (Rupees eighty thousand only)”, the words and figures “₹ 1,20,000 (Rupees one lakh twenty thousand only)” shall be substituted.

III. In clause (c), for the words and figures “₹ 2,00,000 (Rupees two lakh only)”, the words and figures “₹ 2,50,000 (Rupees two lakh fifty thousand only)” shall be substituted.

IV. In clause (d) :

(i) For the words and figures “₹ 40,000 (Rupees forty thousand only)” the words and figure “₹ 50,000 (Rupees fifty thousand only)” shall be substituted.

(ii) For the words and figures “₹ 1,60,000 (Rupees one lakh and sixty thousand only)” the words and figures “₹ 2,00,000 (Rupees two lakh only)”, shall be substituted.

2. These Amendments shall effect from the date of issue of this Amendment.

The Lieutenant-Governor of Puducherry, is pleased to hereby make the following further amendments to the Scheme “Grant of State Award for the Welfare of Differently Abled Persons (Amendment) Rule 2015” (hereinafter referred to as the said rules) which was originally notified *vide* G.O. Ms. 25/2000-Wel (SW-II), dated 29-09-2000 of the Chief Secretariat (Welfare), Puducherry and amended *vide* G.O. Ms. 25/2000-Wel (SW-II), dated 29-09-2000 and G.O. Ms. 61/2012-Wel (SW-V), dated 26-04-2012 of the Chief Secretariat (Welfare), Puducherry, namely:—

AMENDMENT OF RULE 6

In Rule 6 (2) (a) of the G.O. Ms. 61/2012-Wel (SW-V), dated 26-04-2012 of the Chief Secretariat (Welfare), Puducherry; for the letters and figures “₹ 10,000”, the letters and figures “₹ 20,000” shall be substituted.

In Rule 6 (3) (a) of the G.O. Ms. 61/2012-Wel (SW-V), dated 26-04-2012 of the Chief Secretariat (Welfare), Puducherry; for the letters and figures “₹ 15,000”, the letters and figures “₹ 25,000” shall be substituted.

In Rule 6 (4) (a) of the G.O. Ms. 25/2000-Wel (SW-II), dated 29-09-2000 of the Chief Secretariat (Welfare), Puducherry; for the letters and figures “₹ 25,000”, the letters and figures “₹ 35,000” shall be substituted.
