அறிவிக்கை

உழவர்கரை நகராட்சியில் உள்ள சாரம் வருவாய் கிராமத்தில், புதியதாக உருவாக்கப்பட்டுள்ள புதிய சாலை பகுதிகளில் விவரங்கள் அடங்கிய பட்டியல் கீழ்க்கண்ட அட்டவணையில் விளம்பரப்படுத்தப்பட்டுள்ளது. அவ்வட்டவணையில் விவரிக்கப்பட்டுள்ள வீதிகள் அனைத்தும் பொதுமக்கள் பயன்படுத்துவதற்குத் தேவைப்படுவதால், 1973-ஆம் ஆண்டு புதுச்சேரி நகராட்சியின் சட்டம் பிரிவு 256 அதிகாரத்தின்படி நகராட்சி பொது வீதிகளாக அறிவிக்க உத்தேசித்துள்ளது. மேற்படி, பொது வீதிகளாக அறிவிக்க உள்ள நிலத்தின் உரிமையாளர்கள் / பட்டாதாரர்கள் அல்லது வாரிசுதாரர்களுக்கு அல்லது தொடர்புடையவர்களுக்கு அல்லது நகர் பிரிவை சேர்ந்தவர்களுக்கு ஏதேனும் ஆட்சேபனை இருந்தால் இவ்வறிவிக்கை வெளியிடப்பட்ட முப்பது (30) நாட்களுக்குள் எழுத்துப் பூர்வமாக இந்நகராட்சிக்குத் தெரிவிக்கும்படி கோரப்படுகிறது. அவ்வாறு முப்பது (30) நாட்களுக்குள் ஆட்சேபனை ஏதும் பெறப்படவில்லை என்றால் இவ்வட்டவணையில் குறிப்பிடப்பட்டுள்ள சாலைகள் பொதுமக்களின் உபயோகத்திற்காக எடுத்துக்கொள்ளப்படும் என்பதனை இதன்மூலம் அறிவிக்கப்படுகிறது. மேலும், கீழ்க்கண்ட அட்டவணையில் உள்ள சாலைகள் அனைத்தும் நில அளவீட்டு புத்தகம் (FMB) மற்றும் சாலை தற்போது உள்ள அளவீடுகளின்படி ஒப்பிட்டு கொடுக்கப்பட்டுள்ளது. பிற்காலத்தில் சாலை மற்றும் மனைகளின் அளவுகளில் ஏதேனும் ஆட்சேபனை பெறப்பட்டால் அதற்கு நகராட்சி பொறுப்பேற்காது என்றும் தெரிவிக்கப்படுகிறது.

மேலும், கீழ்க்கண்ட அட்டவணையில் விவரிக்கப்பட்டுள்ள வீதிகளின் வரைபடங்களை அலுவலக நேரங்களில் நகராட்சி பொறியியல் பிரிவில் அணுகி பார்வையிடலாம்.

அரசு பொது மருத்துவமனை, காரைக்கால்

ஒப்பந்தப்புள்ளி அறிவிப்பு

காரைக்கால், அரசு பொது மருத்துவமனையில் உள்ள இம் மருத்துவமனையை சார்ந்த 2007 முதல் 2018 வரை உள்ள பழைய மருத்துவ பதிவேடுகள் (Case Sheets) எக்ஸ்ரே பிலிம் நீங்கலாக, அவை இருக்கும் நிலையிலே வாங்குவதற்கு அரசுக்கு முத்திரையிடப்பட்ட ஒப்பந்தப்புள்ளிகள், காரைக்கால், அரசு பொது மருத்துவமனை மருத்துவ கண்காணிப்பாளர் அவர்களால் வரவேற்கப்படுகின்றன.

2. மூடி அரசுக்கு முத்திரையிடப்பட்ட உறையின் மேல் “பலவகைப்பட்ட பழைய மருத்துவ பதிவேடுகள் வாங்குவதற்கான ஒப்பந்தப்புள்ளி” என்று குறிப்பிட்டு அடிக்கோடிட்ட ஒப்பந்தப்புள்ளி வருகிற 17-11-2025 அன்று நண்பகல் 12.30 மணிக்குள் இவ்வலுவலகத்திற்கு வந்து சேரவேண்டும். விலை மொத்தமாக குறிப்பிட வேண்டும். அவைகள் அன்று மாலை 3.30 மணிக்கு வருகைகொடுத்திருக்கும் ஒப்பந்ததாரர்கள் முன்னிலையில் திறக்கப்படும். அதிகமான

தொகை கோருபவரே பொருட்களை வாங்குவதற்கான ஒப்பந்ததாரராக கருதப்படுவார். ஒப்பந்தப்புள்ளி திறக்கப்படும் நாள் விடுமுறை நாளாக அறிவிக்கப்பட்டால் அடுத்த வேலை நாள் ஒப்பந்தப்புள்ளி திறக்கப்படும் கடைசி நாளாக கருதப்படும்.

3. ஒப்பந்தம் கோருபவர்கள் முன்வைப்புத் தொகையாக ₹ 5,000 (ரூபாய் ஐந்தாயிரம் மட்டும்) வங்கி வரைவோலையை, மருத்துவ கண்காணிப்பாளர், அரசு பொது மருத்துவமனை, காரைக்கால், என்ற பெயருக்கு பாரத வங்கியில் மாற்றத்தக்க வகையில் எடுத்து, தத்தம் ஒப்பந்தப்புள்ளிகளுடன் இணைத்திருக்க வேண்டும். ஒப்பந்த விற்பனையில் வெற்றியடையாதோருக்கு முன்வைப்புத்தொகை ஒப்பந்த விற்பனை முடிந்தவுடன் திருப்பிக்கொடுக்கப்படும்.

4. மேலே குறிப்பிட்டுள்ள காலக் கெடுவிற்குப்பின் வரும் ஒப்பந்தப்புள்ளிகளும், முன்வைப்புத் தொகை இல்லாத ஒப்பந்தப்புள்ளிகளும் ஏற்றுக்கொள்ளப்படமாட்டாது.

5. ஒப்பந்தத்தொகையையும் அதற்குண்டான அரசு நிர்ணயம் செய்த விற்பனை வரியையும் சேர்த்து மொத்தமாக செலுத்தியபின் பொருட்களை எடுத்துச்செல்ல அனுமதிக்கப்படுவர்.

வெற்றிபெற்ற ஒப்பந்தக்காரர்கள் அப்பொருட்களை தன் சொந்த செலவில் 24 மணி நேரத்திற்குள் அப்புறப்படுத்தப்பட வேண்டும். தவறினால் முன்வைப்புத்தொகை திருப்பித்தரப்படமாட்டாது. அத்தொகை அரசு கணக்கில் சேர்க்கப்படும்.

6. அதிகபட்ச ஒப்பந்தப்புள்ளியை ஏற்றுக்கொண்ட பின்னர் பொருட்களின் தரம் பற்றியோ, எண்ணிக்கை பற்றியோ எந்தவொரு புகாரும் ஏற்றுக்கொள்ளப்படமாட்டாது.

7. வெற்றியடைந்தவர் முதலில் மருத்துவ பதிவேடுகளை தூளாக்கும் இயந்திரம் கொண்டு மருத்துவ கண்காணிப்பாளரால் நியமனம் செய்யப்பட்ட அதிகாரிகள் முன்பு தூளாக்கிட வேண்டும். மருத்துவ பதிவேடுகளை தூளாக்கிய பின்னரே அதனை எடுத்துச்செல்ல அனுமதிக்கப்படுவார்கள். பதிவேடுகளை அழிக்கும் இயந்திரத்தினை ஒப்பந்தக்காரர்கள் தன் சொந்த செலவில் எடுத்து வரவேண்டும் அதற்கு உண்டாகும் செலவை அரசு எவ்விதத்திலும் பொறுப்பேற்காது.

8. ஒப்பந்தப்புள்ளி கோருபவர்கள் பட்டியலில் உள்ள பொருட்களை கீழ் கையொப்பமிட்டவரின் அனுமதியோடு 17-11-2025 அன்று காலை 11.00 மணிக்கு பார்வையிடலாம்.

9. எந்த ஒரு ஒப்பந்தப்புள்ளியையோ அல்லது எல்லாவற்றையுமோ எவ்வித காரணமும் கூறாமல் ஏற்கவோ அல்லது மறுக்கவோ மருத்துவ கண்காணிப்பாளருக்கு முழு அதிகாரம் உண்டு. அது சம்பந்தமாக மருத்துவ கண்காணிப்பாளரின் முடிவே இறுதியானது.

The intending tenderers should enclose a Demand Draft for an amount of ₹ 5,000 (Rupees five thousand only) drawn in favour of the Medical Superintendent, Government General Hospital, Karaikal, as earnest money deposit.
