NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to amend the Guidelines of the Scheme "National Livestock Mission (NLM) - Risk Management and Insurance Scheme" as follows:

AMENDMENT

1. In the Sl. No. C - Scope, D - Eligibility and I - Pattern of Assistance of the G.O. Ms. No. 8/AH., dated 24-07-2015 of the Chief Secretariat (Animal Husbandry), Puducherry, the following shall be substituted:

C. *Scope*.— The assistance by way of subsidy on the Livestock Insurance premium rate for maximum of 10 cattle units per farmer shall be extended to the Livestock rearers to insure their livestock for a period of three years.

D. *Eligibility*.— (3) The applicant is eligible to insure all the permissible 10 cattle units in single year or in subsequent years and will be considered afresh only after a lag period of three years from the date of insuring the 10th cattle.

1. *Pattern of Assistance*.— (i) The pattern of assistance will be as subsidy on the Livestock Insurance premium rate for maximum of 10 cattle units per farmer for a period of three years.

(ii) The pattern of assistance will be based upon the stipulations issued under the National Livestock Mission by the Department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India.

(iii) The present specifications are as follows:

Category of the farmer	Central share	State share	Beneficiary share
Both APL & BPL	85%	Nil	15%

(iv) Payment will be made against the eligible beneficiaries directly to the selected Insurance Company so that the insurance cover can take effect immediately after the Beneficiary / Livestock rearer pays the beneficiary share.

2. All other Guidelines / conditions of the Scheme notified *vide* G.O. Ms. No. 8/AH., dated 24-07-2015 of the Chief Secretariat (Animal Husbandry), Puducherry, remains unaltered. The Amendment shall come into force with immediate effect.

3. This issues with the concurrence of the Finance Department *vide* I.D.No. 61203/FD/F4/A2/2025-26, dated 02-03-2026.
