ORDER

(Under Section 163 BNSS)

Whereas, in view of the proposed visit of the Hon'ble Union Minister of Home Affairs to Puducherry, Scheduled on 08-08-2026 and 09-08-2026, necessary security arrangements are being undertaken by this Administration.

2. And whereas, vide Letter No. B1/SSP (L&O)-RD/2026-304, dated 04-08-2026, the Senior Superintendent of Police (L&O), Puducherry, has requested the declaration of a "No Fly Zone" in Puducherry during the visit of the Hon'ble Home Minister of India.

3. And whereas, as a measure to strengthen security, there shall be restriction on use of Aerial photography / videography in any form by usage of drones, balloons, *etc.*, and hence, there is sufficient ground for proceeding for which immediate prevention is required.

4. Now, therefore, I, Kulothungan. A, I.A.S., District Magistrate, Puducherry, in exercise of the powers conferred upon me by virtue under section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023, with a view to ensure tightened security during the visit of the Hon'ble Union Minister of Home Affairs to Puducherry on 08-08-2026 and 09-08-2026, declare the areas comprising Oulgaret Municipality, as "No Fly Zone" and do hereby prohibit the flying of any kind of aviation devices including UAV, drones, *etc.*, on 08th August, 2026 and 09th August, 2026.

5. Any person violating this order shall be liable for penal action under section 223 of the Bharatiya Nagarik Suraksha Sanhita, 2023 and other relevant provisions of the law.

6. This order shall remain in force on 8th August, 2026 and 09th August, 2026.

7. The emergent nature of case and circumstances do not permit serving of notice to the concerned in due time and hence, this order is passed *ex parte* under section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023.
