All the intending tenderers may inspect the unserviceable items in each and every centres of ICDS Project-III, Ariyankuppam (Zone III-28 centres and IV-30 centres) in Ariyankuppam area. The name of the Anganwadi centres and list of materials are pasted on the Notice-Board of the Department of Women and Child Development, New Saram, Puducherry-605 013 and Office of the CDPO, ICDS Project-III, No. 11, III Cross, Srinivasa Nagar, Ariyankuppam, Puducherry-605 007.

2. The intending tenderers may inspect the materials with the permission of the concerned Anganwadi workers on the following dates 25-08-2026, 27-08-2026 and 28-08-2026 during 10.00 a.m. to 4.00 p.m.

3. The intending tenderers may submit sealed tender covers addressed to the Director, Department of Women and Child Development, Puducherry. The cover should contain the tender amount for the unserviceable materials as detailed below

4. The indenting tenderers should deposit an amount of ₹ 20,000 (Rupees twenty thousand only) in cash as earnest money deposit at the time of submitting the tender covers. The tender covers along with earnest money deposit should reach the undersigned on or before 31-08-2026 at 2.30 p.m. The tender covers received after due date and time will be rejected.

5. The tender covers will be opened on 31-08-2026 at 3.00 p.m. in the presence of tenderers who are present at the time of opening the covers. The tender will be conducted in the Training Hall (III Floor) of the Department of Women and Child Development, Housing Board Building, New Saram, Puducherry.

6. The tenderers should submit the documents such as self-attested copies, of (i) Copy of GST Certificate (ii) Copy of PAN Card and (iii) Copy of Aadhaar Card. If any, false representation is found during the tender process, the tender submitted by him / her will be cancelled and earnest money deposit will be forfeited. The GST Certificate will be verified through online before commencement of the tender. If any, inoperative GST status found, the same tender cover will be rejected before commencement of the tender and earnest money deposit also forfeited.

7. The public vocal auction will be conducted on the spot, keeping the highest amount quoted in the tender form as the minimum amount for the bid to start vocal auction.

8. If any / all participants misbehave during the tender process, the tenderer / bidder(s) will be removed from the place, also their tenders will be rejected and earnest money deposit will be forfeited.
