ORDER

In compliance with the directions of Hon'ble Supreme Court in Crl. A. No. 3177/2025 in Sukdeb Saha Vs. The State of Andhra Pradesh, Guidelines for registration, control and monitoring of Coaching Institutes operating in the Union territory of Puducherry has been issued *vide* G.O. Ms. No. 3, dated 17-02-2026 of Chief Secretariat (Higher and Technical Education), Puducherry.

2. Approval of the Government has been accorded for constitution of the authority for registration, regulation and control of the Coaching Institutions in the four regions of Union territory of Puducherry as below:—

The Committee may cause to issue public advertisement to invite applications for registration from existing Coaching Institutes in accordance with the Guidelines.
