3. (i) This notification is made under the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30 of 2013), to all whom it may concern.
- (ii) A plan of the land may be inspected in the Office of the Sub/Deputy Collector (Revenue) North-cum-Land Acquisition Officer, Puducherry on any working days during the working hours.
- (iii) The Government is pleased to authorize the Sub/Deputy Collector (Revenue) North-cum-Land Acquisition Officer, Puducherry and his staff, to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.
- (iv) Under sub-section (4) of section 11 of the said Act, no person shall make any transaction or cause any transaction of land, *i.e.*, sale/purchase, *etc.*, or create any encumbrances on such land, without prior approval of the Sub/Deputy Collector (Revenue) North-cum-Land Acquisition Officer, Puducherry from the date of publication of this notification.
- (v) Objections to the acquisition, if any, may be filed by the person interested within 60 (sixty) days from the date of publication of this notification as provided under section 15 of the said Act before the Sub/Deputy Collector (Revenue) North-cum-Land Acquisition Officer, Puducherry.
