NOTIFICATION

The Hon'ble Supreme Court of India, in its judgement, dated 30th January 2026 in W.P.(C) No. 1000 of 2022 – Dr. Jaya Thakur *Vs.* Union of India and Ors, has categorically recognized the right to dignified menstrual health as an integral facet of Article 21 of the Constitution, and has further held that access to Menstrual Hygiene Management (MHM) measures is essential for ensuring the right to education and equality of opportunity for adolescent girls.

2. Accordingly, the Health Department, in the wake of the above judgement of the Hon'ble Supreme Court of India and on the directions of the Ministry of Health and Family Welfare, GoI, has proposed for constitution of the District / Regional level committee to ensure the Menstrual Hygiene Scheme under National Health Mission is effectively implemented.

3. Therefore, Hon'ble Lieutenant-Governor, is pleased to constitute the following regional level committees for Monitoring and Regulating the Menstrual Hygiene Scheme in the Union territory of Puducherry with the following composition:
