2. The sealed tenders should be addressed to "The Secretary, Legislative Assembly Secretariat, No. 4, Victor Simonel Street, Puducherry" duly

superscribing on the envelope as "Tender for purchase of e-waste items" and should reach this office on or before 5.00 p.m. on 01-07-2026. The tenders will be opened on 02-07-2026 at 11.00 a.m. in the presence of the tenderers if any, in the chamber of the Secretary, Legislative Assembly Secretariat, Puducherry.

3. The tender-cum-auction notice issued, dated 26-05-2026 is hereby cancelled. The tenderer should offer their fresh bid after the date of publishing this re-tender-cum-auction notice.

4. The tenderer / bidder should offer rate for "the entire items as one lot" in his tender / bid. Public auction will be started from the highest rate quoted by the tenderers / bidder. The rate will be effected only to the highest tenderer / bidder.

5. The tender / bid will be awarded to the highest tenderer / bidder.

6. If, the highest tender / bid amount offered by the tenderer / bidder is found to be not acceptable by the undersigned, then open auction will be conducted on the spot, keeping the highest tender/bid amount as the minimum upset price for bid of auction.

7. The intending tenderers / bidders shall deposit an earnest money deposit of ₹ 500 (Rupees five hundred only) along with sealed tenders. The earnest money deposit of the unsuccessful tenderers / bidders will be refunded on the same day soon after completion of the tender / auction sale. The tenders who sent sealed tender through post should send earnest money deposit through Demand Draft only in favour of DDO, Legislative Assembly Secretariat, Puducherry.

8. The successful tenderer / bidder shall pay the entire amount within 3 days soon after the completion of the tender / auction sale and should clear the sold materials at his / her own arrangements / cost before 5.00 p.m. on the same day of payment, failing which this office will not be held responsible either for the safe custody or for loss or damage of articles once the tender / auction sale is over.

9. The successful tenderer / bidder shall make payment of GST directly to GST account on reverse charges basis.

10. No claim on the quality of the articles will be admitted once the tender / auction sale is over.

11. The intending tenderers / bidders can inspect the articles from 10.00 a.m. to 12.00 noon on any working day but, on or before on 01-07-2026 at this office with the permission of the undersigned.

12. The tenders offered after the due date and time will be rejected.

13. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof and the decision of the undersigned in this regard will be the final and binding on all the tenders / bids. If, the tender / auction date falls in a public holiday (or) if, the Legislative Assembly is in sitting, the tender / auction sale will be held on the next working day.

14. Along with the tender / bid, a copy of all the following self-attested documents should be submitted by the tenderers / bidders.

(a) Identity Card of the authorized person of Company / Firm.

(b) Valid GST Certificate.

(c) Copy of authorization / registration issued by the Central Pollution Control Board for recycling.

15. Individuals / Partner of a firm who have / has been punished under CrPC/IPC/BNS/BNSS or any criminal case under process, is not eligible for participating in the tender-cum-auction. If, any false representation is found during the tender / bid process, the tender offered by them / him will be cancelled and their / his earnest money deposit will be forfeited.

16. If, any participant(s) misbehaves during the tender / auction process, the tenderer(s) / bidders will be removed from the place of auction and also his / her / their tender(s) will be rejected and the earnest money deposit will be forfeited.

Sealed tenders are invited for sale of old, unserviceable articles like aluminum vessels, stainless steel vessels, wood, brass, iron, plastic materials and old story books, waste papers etc., of the various Anganwadi Centres of Zone-III and IV (46 centres) under the control of ICDS Project-I, Villianur, Department of Women and Child Development, Puducherry, will be disposed off in “as-is-where-is-condition”.

Terms and Conditions

1. All the intending tenderers may inspect the unserviceable items in each and every centers of ICDS Project-I Zone-III and IV in Villianur area. The name of the Anganwadi centres and list of materials are pasted on the Notice Board of the Department of Women and Child Development, New Saram, Puducherry-605 013 and Office of the CDPO, ICDS Project-I, Moopanar Complex, Villianur, Puducherry.

2. The intending tenderers may inspect the materials with the permission of the concerned Anganwadi workers from 15-07-2026 to 17-07-2026 during 10.00 a.m. to 4.00 p.m.

3. The intending tenderer may submit sealed tender covers addressed to the Director, Department of Women and Child Development, Puducherry. The cover should contain the tender amount for the unserviceable materials as detailed below:

4. The indenting tenderers should deposit an amount of ₹ 20,000 (Rupees twenty thousand only) in cash as earnest money deposit at the time of submitting the tender cover. The tender cover along with earnest money deposit should reach the undersigned on or before 20-07-2026 at 2.30 p.m. The tender covers received after due date and time will be rejected.

5. The tender covers will be opened on 20-07-2026 at 3.00 p.m. in the presence of tenderers who are present at the time of opening the covers. The tender will be conducted in the Training Hall (III floor) of the Department of Women and Child Development, Housing Board Building, New Saram, Puducherry.

6. The tenderer should submit the documents such as self-attested copies of (i) Copy of GST Certificate (ii) Copy of PAN Card and (iii) Copy of Aadhaar Card. If, any false representation is found during tender process, the tender submitted by him / her will be cancelled and earnest money deposit will be forfeited. The GST Certificate will be verified through on line before commencement of the tender. If, any inoperative GST status found, the same tender cover will be reject before commencement of the tender and earnest money deposit also forfeited.

7. The public vocal auction will be conducted on the spot keeping the highest amount quoted in the tender form as the minimum amount for the bid to start vocal auction.

8. If any / all participants misbehave during the tender process, the tenderer(s) will be removed from the place, also their tenders will be rejected and earnest money deposit will be forfeited.

9. At the end of vocal auction, the successful tenderer should remit the entire amount to the Cashier, Department of Women and Child Development, Puducherry, in cash, immediately after finalization of tender. The applicable rate of GST will be charged on the finalized tender amount as per rules.

10. The rate finalized during auction for sale of old story books and waste paper is valid for one year from the date of auction.

11. The entire unserviceable materials, story books and waste papers should be removed within 3 days from the date of tender at their own risk and cost. No claim on the quantity or quality of the articles will be entertained once the tender is finalized. This office will not hold responsibility for the materials, once the tender is finalized. The earnest money deposit of the successful tenderer will be released after clearing the materials from respective Anganwadi centres.

12. The earnest money deposit amount of unsuccessful tenderers will be returned after the tender process is over on 20-07-2026 after 5.00 p.m.

13. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof, in the interest of the public. In case of any dispute, the decision of the undersigned will be final.
