The reconstituted Juvenile Justice Board shall be for a period of three years from the date of its notification in the Official Gazette and the appointment of Members shall co-terminus with the tenure of the Boards. In respect of the Puducherry region, the Board shall hold its sittings in the premises of Observation Home at Ariyankuppam, Puducherry and in respect of Mahe region, the Board shall hold its sittings in the premises of Department of Women and Child Development, Mahe.

3. The Members of the Board shall be paid honorarium of ₹ 2,000 for each sitting and TA / DA as admissible to the Group 'A' Officer of the Government of Puducherry to attend the meeting.
