NOTIFICATION

In supersession to the G.O. Ms. No. 1/DIT/2025-26, dated 02-04-2025 of this Directorate, the Government of Puducherry has operationalised the CSC Scheme under National e-Governance Plan (NeGP) and has been rendering various G2C, B2C services through the Common Services Centres (CSCs). The following Departments, viz.,

(i) Department of Agriculture and Farmers Welfare, (ii) Transport Department, (iii) Department of Civil Supplies and Consumer Affairs, (iv) Department of Fisheries and Fishermen Welfare, (v) Directorate of School Education, (vi) Local Administration Department, (vii) Department of Personnel and Administrative Reforms, (viii) Registration Department, (ix) Directorate of Social Welfare, (x) Town and Country Planning Department, (xi) Department of Women and Child Development, (xii) Pondicherry Ground Water Authority and (xiii) Electricity Department, Puducherry has been rendering various services to the public through online / offline mode by collecting prescribed fee for certain services. With an aim to streamline and expand access to these services, it has been proposed to render the following services of the Departments of the Union territory of Puducherry in online mode through the Common Services Centres (CSCs) approved by this Administration.

3. The Directorate of Information Technology, Puducherry may revise the user charges from time to time. The user charges shall be applicable for every District in the Union territory of Puducherry uniformly. A citizen can avail any of the Government to Citizen (G2C) services as included in the CSC Scheme, from any CSC, along with all requisite documents prescribed by the Department and pay the designated statutory fee and user charges as detailed in this notification. The Village Level Entrepreneur / Common Services Centre-Special Purpose Vehicle (CSC-SPV) created under Department of Electronics and Information Technology (DeitY), Ministry of Communications and Information Technology, Government of India, shall be responsible for delivery of the online services to the citizen.

4. This order shall come into force with immediate effect and is issued with the concurrence of Finance Department *vide* U.O. No. 28918/FC/FD/F5/A3/2025-26.
