NOTIFICATION

The Government of Puducherry has embarked on a transformative initiative through the launch of the Unified Digital Hub (UDH) Project, a centralized repository that enables seamless online validation, de-duplication and cross-referencing of beneficiary data by various Departments, thereby ensuring that only eligible citizens receive the intended benefits.

The "Apex Committee and Technical Steering Committee for Streamlining the implementation of Various Welfare Schemes" in the Union territory of Puducherry is re-constituted with the following composition and Terms of References are as under:

1. Composition of Apex Committee (by Designation):

Terms of Reference:

- (a) Creation of a unified database of various welfare Schemes.
- (b) Finalizing deliverables.
- (c) Evolving institutional framework of the project fully functional.
- (d) Compliance with the Aadhaar Act and Data Protection Laws.
- (e) Any other issues referred by Technical Steering Committee for guidance / resolution.

2. Composition of Technical Steering Committee (By Designation).

- (a) Development Commissioner-cum- . . . Chairman Secretary (Finance).
- (b) Project Director, DRDA . . . Member
- (c) Director(Planning) . . . Member
- (d) Representative of SIO, NIC, . . . Member Puducherry / NIC Official handling the UDH project.
- (e) Director (IT) . . . Member-Secretary.

Terms of Reference:

- (a) Creation of a Unified database, while eliminating duplication in seeking information from beneficiaries.
- (b) Standard Operating Procedure (SOP) / methodology for implementation.
- (c) Making Aadhaar as the primary identifier and the Family Ration Card number as the secondary identifier for the unified database.
- (d) Standardized formats for application / report.
- (e) Purification of existing databases with a view to de-duplication.

- (f) Making exclusion and inclusion of the beneficiary's systemdriven.
- (g) Finalize the data updation / de-duplication frequency.
- (h) Modalities for the authentication of the Aadhaar linked database, for periodic verifications, such as genuineness of claims, elimination of death cases, *etc.*
- (i) Creation of Mobile Application.
- (j) Integration of Artificial Intelligence and data analytics tools to improve service quality and deliver predictive Governance.
- (k) Creating a robust system architecture.
- (l) Any other work entrusted by the Apex Committee from time to time.
3. The two committees shall monitor to achieve the task of regulatory framework and will have the following responsibilities.
- Directorate of Information Technology will be the Nodal Department and in-charge of Central Repository. The Unified Database will be the

backbone for Central Repository. All the cross-reference requirement will be approved by Directorate of Information Technology.

- NIC will assist and provide technical support for the Central Repository necessary web services, record format specifications provide access controls, Audit trails and work flow-based system.
- Nodal Department for each Scheme specific detail will be identified.
- The Member-Secretary of the two Committees will call for the meeting as per the work requirement.
- The Committees shall remain in existence for the duration of the UDH Scheme.

4. This issues with the approval of the Hon'ble Lieutenant-Governor, Government of Puducherry *vide* File No. 829/LGS/2026 , dated 30-04-2026.
