NOTIFICATION

2. AND WHEREAS, in furtherance of its commitment and vision to significantly improve the Ease of Doing Business and Ease of Living, the Government of Puducherry has been progressively reducing the compliance burden on the existing and new enterprises in the Union Territory of Puducherry;

NOW, THEREFORE, in exercise of the powers conferred under Section 12 of the Puducherry Town and Country Planning Act, 1969 and the rules made thereunder, the Government of Puducherry is pleased to notify the Puducherry / Karaikal / Mahe / Yanam Planning Authority as the Nodal Agency and Single Point of Contact for facilitating and coordinating the issuance of all required 'No Objection Certificates' (NOCs) and approvals relating to buildings and construction activities for commercial, industrial, institutional and mixed-use establishments within the jurisdiction of respective Puducherry/Karaikal/Mahe/Yanam Planning areas, as notified by the Government from time to time.

4.. All the concerned Line Departments, Local Bodies and the Statutory Authorities shall extend necessary co-operation to the respective Planning Authority for the timely processing and issuance of the required NOCs and approval.

5. This Notification shall come into force with immediate effect.
