### **SCHEDULE** RECRUITMENT RULES FOR THE POST OF FOREMAN

1. Name of the post Foreman

2. Number of Post 11 (Eleven) (2023)

(Planning & General – 4

Binding – 4

Maintenance - 1

3. Classification Subject to variation dependent on work load

"General Central Services - Group "B" (Non

Gazetted) - Non-Ministerial"

4. Level in the Pay Matrix Level 6

5. Whether Selection or non selection selection post

6. Age limit for direct recruits Not exceeding 30 years (Relaxable for Government Servants upto 5 years in accordance with the orders or instruction issued by the Central Government)

Note: The crucial date for determining the age-limit shall be as advertised by the Competent Authority

7. Education and other qualifications required for direct recruits

#### **Essential:**

Diploma in Printing Technology with 5 years supervisory experience in all field of, Desk Top, Publishing, preprinting, printing, Binding, costing, estimating and inventory control.

#### Desirable:

Degree in Printing Technology with 2 years supervisory experience in all field of, Desk Top, Publishing, preprinting, printing, Binding, costing, estimating and inventory control.

Note-1: Qualifications are relaxable at the discretion of the Competent Authority for reasons to be recorded in writing, in the case of candidates otherwise well qualified.

Note- 2: The Qualification regarding experience is relaxable at the discretion of the Competent Authority for reasons to be recorded in writing in the case of candidates belonging to Scheduled Castes or Scheduled Tribes if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them

8. Whether and educational age qualifications prescribed for direct recruits will apply in the case of promotees

Age - No

Educational Qualification: No

9. Period of probation if any,

Two years for direct recruits.

Note: Direct recruits would be required to successfully complete a mandatory induction training of at least two weeks duration, as prescribed by the competent authority for completion of probation

10. Method of recruitment, whether by direct recruitment or by promotion or by deputation/ transfer and percentage of the vacancies to be filled by various methods

By promotion, failing which by direct recruitment

11. In case of recruitment by promotion/ deputation / transfer, grades from which promotion /deputation / transfer is to be made Departmental Promotion Committee

#### Promotion:

- a) Section Holder(Planning & General) with 6 years regular service in the grade for Foreman(Planning & General)
- b) Section Holder(Binding) with 6 years of regular service in the grade for Foreman(Binding)
- c) Section Holder(Maintenance) with 6 years regular service for Foreman(Maintenance)
- d) Desk Top Publishing Operator with 6 years regular service in the grade for Foreman(Desk Top Publishing)

Note -1: The eligibility service shall continue to be 3 years for persons holding the feeder post on regular basis on the date of notification of these rules.

Note -2: Where juniors who have completed their qualifying/ eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of requisite qualifying/ eligibility service more than half of such qualifying/ eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed scuh qualifying/ eligibility service
